**Leagues typically have two or three seasons per year and each season will have a charge.

***Leagues are responsible for managing the collection of non-resident fees. Non-Resident fees are annual based January to January. Leagues must provide GSCDD with a league roster listing (at a minimum) all players names and address. Addresses will be verified by GSCDD. Note: Youth rosters are protected under the Sunshine Laws and may not be distributed.

**All league fees are due 30 days prior to the start of any regular season.*

Basic Park Rules

1. Parks are open for public use during posted hours.
2. You must have your reservation copy with you during the event.
3. Conduct no activity which might damage park facilities.
4. Please use only designated parking areas.
5. Obvious violations of expected attendance stated on reservation subjects group to loss of reservation.
6. No equipment may be moved or relocated without written permission from the GSCDD Parks & Recreation Leader.
7. A damage-clean up assessment may be applied to anyone reserving field usage, at the GSCDD's discretion.
8. Prioritization of field usage is schedule driven.
